



# 2009 "Freedom of Speech" POSTER CONTEST

## Contest:

The Illinois First Amendment Center (IFAC) and the Illinois Press Foundation (IPF) are pleased to announce their fourth annual Poster Contest for Illinois High School students, grades 9 – 12. The winning posters will be those that best portray **Freedom of Speech** as guaranteed by the U.S. Constitution's First Amendment. Cash prizes will be awarded in the following amounts:

1st Place - \$1,000 • 2nd Place - \$750 • 3rd Place - \$500 • 4th Place - \$250

Honorable Mention Awards - \$100 each

Creative Recognition Awards for original art posters only (hand-drawn or painted only) - \$100 each

## Eligibility:

Students who presently reside in Illinois and are enrolled in an Illinois high school or home school are eligible.

## Rules & Specifications:

- Poster theme must clearly be Freedom of Speech. No other themes will be accepted. Slogans/taglines encouraged.
- One entry per student. No group projects will be permitted.
- Any artwork that does not come with accompanying Entry Form securely attached to the back of art will be disqualified.
- Entries may be sent to the IFAC (see address below) or may be brought to this address. All entries must be received at the IFAC or brought in no later than 4:30 p.m. CST on Monday, January 3, 2010.
- Preferred size: 14" w X 20" h. Minimum acceptable size: 8 ½ X 11; maximum acceptable size: 14" X 20."
- Artwork may be hand-drawn, painted, or computer-generated. If computer-generated, you may shoot your own digital photographs for the composite, submit original illustrations from Adobe Illustrator or similar software, or use royalty-free images. Suggested resolution and format are: 600 lpi in either JPG or PDF format.
- **All** artwork entries become the property of the IFAC and will not be returned to the entrant.
- The judges of the contest are the final arbiters in awarding all prizes.
- Only prize winners and a designated teacher (if listed on Entry Form) will be notified via e-mail. If you do not have e-mail, please list your teacher's email address or other individual's email address, so we may reach you. Any winner not reachable will be disqualified.
- A press release containing the following information about each prize winner will be sent to all Illinois newspapers who are members of the Illinois Press Association: Student's name and grade level, prize won, name and city/town of student's school, and name of art teacher, if applicable.
